We are proud to announce the publication of the 25th issue of *Uluslararası Suçlar ve Tarih* / *International Crimes and History (UST / ICH)*, marking another milestone in contributing to the fields of international law and historical analysis. This issue is particularly significant as it occurs during a year defined by major geopolitical shifts and legal developments, reflecting our ongoing commitment to deepening the understanding of complex international conflicts, crimes, and conflict resolution mechanisms.

This landmark issue includes the special section titled "Historical Legacies and Their Impact on Modern Legal Systems and Identity Politics," which explores how historical inheritances influence contemporary global issues, with a focus on colonialism, ethnic and cultural conflicts, and their impacts on current human rights concerns across regions like the Levant, Asia, and Africa.

The first research article in our special section, "Dehumanization's Ancient Origins and Its Impact on Enlightenment" by Soner Tauscher and Yiğit Cem Eskicioğlu , investigates the roles of prominent Western philosophers in shaping views on race, nature, linking these views to modern slavery, and human racism and dehumanization. Yekta K. Novan provides insights into the colonial experiences in early 20th-century South Africa compared to earlier German colonial policies in " Colonialism, The German Experience and Thoughts on History | A Case Study of South Africa." Yusuf Halil Calip offers a detailed analysis in "The Evolution and Reasons of a Distinct Hong Kong Identity Through Historical Processes," discussing how unique laws and agreements have shaped Hong Kongs distinct path from mainland China's policies.

As we reflect on these scholarly contributions, we extend our gratitude to our readers and contributors who have been part of our journey and invite you all to explore these compelling discussions in our 25th issue.
